#### **DECLARATION**

#### THE PARTNER UNIVERSITIES HAVE AGREED AS FOLLOWS:

# I. Purpose of the addendum

The purpose of this addendum is to record the decisions of the Partner Universities to ensure continuity of the European Joint Master Degree (JMD) Programme in Image Processing and Computer Vision (IPCV), once finalized the Grant Agreement Number 2017-1923, dated 04.09.2017 between the Education, Audiovisual and Culture Executive Agency (EACEA) and the IPCV Consortium, and according to the EACEA indications that this grant should be focused on implementing a sustainable Programme.

These decisions complement the Consortium Agreement signed by the Partner Universities (signed by PPCU 08/10/2018, UAM 15/10/2018 and UBx 16/10/2019) and just affect two of its annexes:

- Annex B: Programme Description. The name of the diploma delivered by UAM is modified
  according to National restrictions; the names of the diplomas delivered by UBx and PPCU are
  updated; and the list of compulsory and optional courses is also updated. These modifications are
  included in a new Annex B.1
- Annex C: Financial Scheme. A new Annex C.1 is included to reflect the specific financial agreements for the cohorts not funded by the EACEA.
