I am Full Professor at the Department of Economic Analysis at the University Autonomous of Madrid. I am an applied microeconomist interested in education and labor market issues as



well as issues related to poverty, deprivation and well-being. I have long expertise in the coordination of scientific projects, both at European, national and regional levels. In particular, I have been the main research of one Project of the 7th Framework Programme of the European Commission (2008-2011); two National Plan Projects (ECO2008-04813/ECON (2009-2011); and PID2019-111765GB-I00 (2020-2023)); and 1 regional project funded by Madrid regional government (CCG07-UAM/HUM-1654, 2008). My experience as coordinator also extends to projects funded by other institutions of national relevance, such as Fundación Ramón Areces (2 projects as main researcher; 2012-2014 and 2015-2017) and Observatorio Social La Caixa (1 project; 2019-2020). I've also been a member of the international network *LoWER - European low-wage employment research network* (Comisión Europea), and I have collaborated as a member of the research team in a total of 12 competitive projects funded by different public institutions. The results of my research activity have been mainly published in international journals included in the JCR database such as *European Economic Review*, *Economic Modelling*; *Economics of Education Review*, *Journal of Economic Psychology*, *Journal of Economic Inequality*, *Economics and Human Biology*, *Review of Income and Wealth*, and *Socio-Economic Review*, among others.

My participation in more than 15 consultancy projects with the Regional Government of Madrid and other public/private entities (Instituto de Estudios Fiscales, Observatorio Social La Caixa, European Commission) attests to my extensive experience in knowledge transfer activities. The results of these projects have been published in reports of a highly informative nature. I am also the coordinator of a consolidated research group at Autonomous University of Madrid integrated by 10 researchers belonging to this university that are experts in the fields of Education, Labour and Health Economics. Moreover, at this university I actively participate in the supervision of Master's theses within the Master in Quantitative Economic Analysis.

I actively participate in the evaluation of the research. Specifically, I have collaborated with the *Agencia Nacional de Evaluación y Prospectiva* (ANEP) in the evaluation of 17 competitive research projects. I have also collaborated in tasks of this type with the La Caixa Social Observatory. My involvement in research evaluation also extends to my participation in more than 10 thesis tribunals, as well as my role as an anonymous evaluator in different national and international journals. Since July 2021 I hold the position of Vice-Rector for Research and Library at Autonomous University of Madrid. This position has allowed me to play an important role in both the evaluation of research and its management within this university.

Finally, I have three six-year research periods recognized by the National Commission for Assessment of Research Activity (CNEAI).
