## **Description of the program**

Double Degree in Law and Business Administration is designed to provide students with a clear and sound understanding of the current and future economic and social needs. It is a fine example of a desirable and feasible degree that allows students to gain comprehensive and integrated training in both fields. Moreover, the degree aims at delivering and meeting growing demand for disciplines and training needed in the legal and business environment.

### Why choose this double degree?

There are a number of reasons to choose a Double Degree in Law and Business Administration. First of all, the complexity of business world requires the possession of a broad variety of skills and competencies that need to be developed with a close understanding of the rules that govern the business world, which means knowledge of the national and international legislation that correspond with all business actions.

Secondly, the training in two areas provides a global and interconnected vision that entitles students not only with a close knowledge of the social and economic reality but also increases their employability and trains them to be protagonists of the future.

### What will you learn?

Graduates of the Double Degree Program in Law and Business Administration finish their studies with two degrees that complement each other and enhance their ability to conduct multidisciplinary, interconnected and integrated analysis. Its academic goal is to impart thorough knowledge in areas that are as interesting and relevant as necessary for the formation of a versatile specialist who is perfectly prepared for the needs of the labor market.

As the Double Degree in Law and Business Administration contains the full content of each separate degree, it demands higher dedication than other traditional degrees and is accompanied by a longer duration, although it is shorter than studying both degrees separately.

The program provides theoretical and practical training in the areas of Law and Business Administration. It integrates the expertise of each of the degrees but also adds a much wider concept that allows an approach facilitating global understanding and promoting the interconnectedness of its related and comprehensive areas. In summary, the program allows students to develop strong competences, as well as their analytical and critical thinking.

### Other opportunities (internships and study abroad, etc.)

In the fifth year of the Double Degree in Law and Business Administration, students have to complete an obligatory internship in companies or law institutions. Those can be national or

international internships, in companies and institutions with which the Faculty has signed an agreement.

The student mobility is integrated and fully recognized within the academic curriculum. Additionally, the degree offers students an opportunity to access scholarships for a part of their studies spent abroad in universities and center which the Universidad Autónoma de Madrid has international agreements with.

## **Employability of graduates**

As commonly known, being well prepared with a solid, broad and versatile education increases the chances of having a successful career. The Double Degree in Law and Business Administration gives a unique opportunity to enhance career opportunities. Double Degree in Law and Business Administration is highly valued in the labor market which expands possibilities of employment.

In fact, the comprehensive training provided by the degree increases the success rate of finding a first job. It is worth to mention that about 90% of graduates started working in a field related to their studies within one year after graduation.

These favorable results are linked to the fact that graduates are able to work in a broad variety of professional careers, ranging from companies, law firms, tax consultancy agencies to foundations, business associations and NGOs. To sum up, graduates can aspire to be employed as prosecutors, judges, notaries, registrars, tax inspectors, labor inspectors, state economists or statisticians.

#### Curriculum

To obtain the Double Degree students have to complete 360 ECTS credits over the course of six years, following a balanced and well-structured plan (60 credits per year and 30 credits per semester) based on sequential learning.
