

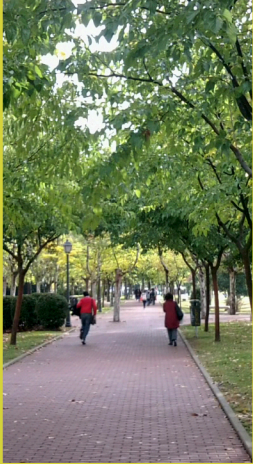

The Master in Microfinance and Financial Inclusion offers **specialized up-to-date and high quality training** in microfinance as a tool to promote financial inclusion of society's most marginalized members.
