FREQUENTLY ASKED QUESTIONS AND ANSWERS

1. Language requirements

- Good level in Spanish is compulsory in order to work in groups, attend courses and take exams (no official certificate required). We strongly recommend that incoming Erasmus students (undergraduate) have at least B2 level of Spanish according to the Common European Framework of Reference for Languages (CEFR).

2. What to do before arriving to UAM

4. Public transport information

Master programmes at UAM (5th / 6th year) have their own academic calendar, including different terms. Information about their schedules and begin-end dates is available only on the website for that specific programme.

9. Now my University has nominated me, what should I do?

First, you need to register / **complete your on-line exchange student application** on the **SIGMA platform**. Application periods for incoming students are:

- o May 15th to June 15th, first semester (Fall) and full-year mobilities
- o until October 31st, second semester (Spring) mobilities

Please, make sure you have a recent photo (passport size picture) before you begin the process. Only .JPG image files are accepted. This is the only document you need to submit during the on-line application.

There are **two sections**:

- a) you will need to register as a user, and then
- b) complete an application informing about:
 - a. Where you are coming from (home university)
 - b. The Faculty you are coming to (select Facultad de Ciencias Económicas y Empresariales or “Facultad de Económicas”).
 - c. What studies you are doing with us.
 - d. It is very important that you upload your photo correctly. If you do not do this, your application will not be processed.

Your admission letter will be emailed to you in approximately 3 weeks from our main mobility office: erasmus@uam.es or serim.movilidad@uam.es for the rest of exchange programmes.

Once your on-line application has been sent, make preparations about your Learning Agreement:

- Get ready to have your Learning Agreement approved. We *recommend* you having a first version of your Learning Agreement before June 15 if you are a first-semester of full-year student; or before October 31st if you are a second semester student. If you have any questions relating to course content or adequacy, your academic coordinator is the right person to help you.
- Keep in mind **that our office does NOT need you to submit your Erasmus+ Learning Agreement**. In case your home university requires you to do so and you need a signature from our side on your Learning Agreement, email us with a copy of the document. Before official enrollment in the courses (matricula), it will be a provisional signature. Instructions on how to get your final Learning Agreement signed is published on our website.
- If you are an exchange student from a non-Erasmus + institution, please follow the directions from our main Mobility Office (serim.movilidad@uam.es)
- **NOTE** that the subjects in your Learning Agreement may vary once the course selection process starts

We will provide you with additional information about how to select and book your courses / groups at the UAM Faculty of Economics, in due time.

10. How do I select my courses? (except for Free movers, Doble degree Paris-Dauphine or Master students)

- By late Spring, we will send you an email with a link to the **course selection website** (ori.feco.uam.es) where you can find all the courses available for international students. If you will only be here for the second semester, you will receive the information in November. Please, for better identification, use your real name and the same email address you used for Sigma when registering.
- The spots available for each course are different, and they will be filled in a **first-come-first-served** basis. This means that, once a course is full, no more international students will be accepted in it. Please, think of different options to complete your learning agreement.
- NOTE that you will see the code (five digits), name of the subject, and the group number (three digits). You will be able to locate the subject in the schedule by their code. There are different groups for each course, and they determine the hours they will be taught. **Attendance is often mandatory**, so make sure you don't have two courses at the same time! Groups at the evening are less crowded. Please consider these courses, as the chances of having a spot in them are higher.
- The schedule for next year is not yet published, you will have it when we send you the information about ori.feco.uam.es

- Once you are finished, you will be able to print your course selection. Please, save that pdf file as proof. However, this is not your official registration. Our office will enroll you in the courses you have selected in SIGMA, before the semester starts. Your “**matrícula**” (downloadable from SIGMA) is your **official enrollment document**. There may be last-minute changes to courses that could affect your selection. If this happens, we will let you know as soon as possible and offer you other options.
- Ori.feco.uam.es will be open for students during two periods: before the semester begins (June, for first-semester and full-year students; and November for second-semester and full-year students).
- Once classes start, students can attend their courses and make changes if needed during first week of classes. After this period, no changes will be allowed in your selection.

11. I am interested in courses from other Faculties, how to proceed?

- In case you are interested in taking courses from other Faculties, you should request them through the on-line form. This form will only be **active during a specific period** and you will be informed about the dates.
- Admission to courses belonging to a different UAM Faculty might be subject to the availability of spots in the early weeks of each semester. Some Faculties have important restrictions concerning the admission of additional students to their English-taught courses (specially Filosofía y Letras / Arts). Answers to your request can take up to 3 weeks.
- Admission to courses from a different Faculty might be subjected to specific limitations. Please see the section “Study contract” here:

12. Which courses are available for international students?

- As a general rule, all courses offered in our Faculty are available for you except for **1st year** courses (groups with format **X1X**), and groups ending with 9 (**XX9**).

13. Do you have limits regarding ECTS per period?

- The maximum number of ECTS awarded per semester: 30 ECTS
- The maximum number of ECTS awarded per academic year: 60 ECTS
- No minimum required, but at least 1 course

14. How do I apply for Master courses?

If you wish to study master-level courses here at UAM (5th / 6th year), you should send to ori.economicas@uam.es the following information before June 15th (first-semester student) or November 15th (second-semester students):

- i. CV
 - ii. Transcript of courses taken at your home university.
 - iii. Letter stating your motivation to request the master courses selected at UAM.
 - iv. Proof of language level.
 - v. Proof of being a Master student.
- o Master students are evaluated and accepted by the Master coordination team only, the IRO cannot make this decision. If the Master coordinators does not accept your request, you can take 4th year courses. No application will be considered after the deadlines, so please, be sure to send all your documents on time.

 - o Remember that the maximum number of ECTS per semester is 30 (60 for the full year).
 - o DO NOT FORGET TO CHECK THE **SCHEDULE** FOR EACH MASTER PROGRAMME, since they might have different terms and start-end dates.

15. Official enrollment (matrícula) in courses, how and when?

- We, the International Relations Office, will enroll you in the courses you have selected **previously** through the course selection website ori.feco.uam.es. Please pay attention to the e-mail you will receive with the dates of when to reserve your spots. This website will be active during specific dates.

16. What should I do once I arrive at UAM?

- First you should register yourself in the office called **Servicio de Relaciones Internacionales y Movilidad** (SERIM) located at Plaza Mayor building on the UAM campus. A copy of your passport / id and health insurance is required. If you need your attendance certificate signed and stamped, they will do that for you.
- Once you have registered your arrival, you might ask for your **certificate of presence** / arrival date.

17. Who will sign my Learning Agreement

- Your Learning Agreement will be signed, by your academic coordinator at UAM, after your official enrollment in the courses (matricula SIGMA). The instructions on how to get your LA signed is published on our website
- When you need your provisional Learning Agreement to be signed before your arrival, please send the document to us and we will have it signed for you. Email: ori.economicas@uam.es

18. Do you offer Spanish courses?

- Spanish courses can be taken at our Foreign Language Service. You can contact them through email: servicio.idiomas@uam.es.

- In case you take the Spanish course, they will issue a separate certificate worth 4 ECTS. This course should not be included in your Learning Agreement as this course is not offered by our Faculty.

19. Extension of period

- Deadline for extension period requests is **November 15**. First semester students who are interested in extending their stay to a whole academic year need to obtain approval by home University and our Faculty before deadline.

20. Internship during period

- ECTS for internship can only be registered once you have found a company where to complete the internship. International student's don't have access to the offers UAM receives for their own students.

21. Transcript of Records

- At the end of your stay with us, your Transcript of Records will be sent directly to your home University. They will receive the electronically signed Transcript of Records by e-mail.

22. Attendance certificate

- Your attendance certificate with dates of arrival and departure will be signed by **SERIM** at Plaza Mayor (Servicio de Relaciones Internacionales y Movilidad)
