# 2 grants

Attendance on the course "Facilitating Leadership in a Knowledge-based Society"

(IAP-UAM-DRCLAS)

### **OBJECTIVE**

Through its School of Doctoral Studies, Universidad Autónoma de Madrid has announced a call for applications for two (2) grants by PhD students at Universidad Autónoma de Madrid who wish to attend the program "Facilitating Leadership in a Knowledge-Based Society" organized by the International Academic Program (IAP), which operates with the DavidRockefeller Center for Latin American Studies (DRCLAS), assigned 5 ECTS by the School of Doctoral Studies at UAM (EDUAM).

The need for future doctorate degree holders to acquire certain soft skills to allow them to successfully and meaningfully confront different scenarios in their working lives is becoming increasingly more obvious, and this will help them head up different activities in a quickly changing world. The objective of this course is to help the participating PhD students to develop some of those soft skills, including effective communication, teamwork, innovation and critical thinking or the ability to resolve interpersonal conflicts and crisis situations, just to name some. In this sense, the course is aligned with UNESCO's Sustainable Development Goal (SDG) #4, on quality education (https://es.unesco.org/sdgs).

### **PLACE**

The symposium is scheduled as a personal attendance event in a lecture room on the Harvard University Campus (29 Oxford Street, Harvard University Campus, Cambridge, MA 02138). Providing that the health situation permits it, the course will be attended in person (further information about this will be provided in due course).

### **DATES**

27th June - 1st July 2022.



### **GRANTS**

- 1) Registration fees: US \$1,500 (40% covered by IAP and the remaining 60% by EDUAM).
- 2) Travelling expenses: € 1,000 (EDUAM)

These grants will not cover any other expenses or procedure, regardless of whether the course organizers provide affordable accommodation, insofar as this is possible.

# **APPLICANTS' REQUIREMENTS**

- 1) To at least be registered in the third tutelage year of a PhD Program at EDUAM.
- 2) To accredit C1 level of English.
- 3) Not to have previously benefited from this grant.

- 1) Letter of interest (maximum 1000 words) specifically stating the PhD Program and the year of thesis tutelage in which the applicant is registered. As a reference, the form provided in Annex 1 to this application can be used.
- 2) Updated CV to which the document describing your PhD activities and accreditation of your level of English should be attached, and any other merits specifically related to internationalization, responsibility and leadership. As a reference, the form provided in Annex 2 to this application can be used.

#### **EVALUATION**

Applications will be evaluated by the Steering Committee of the School of Doctoral Studies.

The following aspects will be specifically taken into account for evaluation purposes:

- Letter of interest.
- Having spent time abroad or having participated in international educational activities during doctoral studies.
- Having participated in educational activities involving responsibility and leadership, and organization of events and days.
